# **Project 1: Production of meta-analysis**

# Objective

■ To use the quantitative review of articles, on the impacts of prejudice and discrimination on the health and wellness of sexual minority persons, to conduct a meta-analysis.

# **Project 2: Production of critical paper examining the measurement of discrimination experiences**

## Objectives

- To critique the ways in which discrimination is currently measured in the empirical literature.
- Assessment of the psychometric properties of existing measures (strengths and limitations).
- Outline the need for scale development.
- Highlight specific issues for consideration such as the frequency and salience of multiple identities, as well as contextual variables that introduce complexities and nuances.

# Project 3: Development and validation of a measure of discrimination that accounts for multiple identities/marginalities.

#### Objective

• On the basis of the completed review above and the review currently underway with Shari Brotman (Refugees and Immigrants) and Janice Ristock (Aboriginals), develop and preliminarily validate a measure of discrimination that takes into consideration the frequency, intensity, and balance of multiple identities.

## **UPDATE**

- 1. Transcription of the 21 interviews to better understand subtle forms of discrimination experienced by gay, lesbian, and bisexual men and women, as outlined in report submitted September, 2009
- 2. Analysis of the transcripts and write-up of these data, as outlined in report submitted September, 2009
- 3. Submission of a paper based on the interviews (March 10<sup>th</sup>, 2010), as outlined in report submitted September, 2009

# **Ongoing Research Tasks**

- 1. Based on the results emanating from the paper (above), we know the following: 1) a scale should tap multiple dimensions of discrimination (essentially, moving beyond the workplace); 2) dimensions such as health and familial relationships, for example, should be represented in both subtle and blatant forms
- 2. The scale items taking into consideration the aforementioned points are currently under construction; the list should be completed by my team of graduate students for April 21<sup>st</sup> (the date of my return to Saskatoon)
- 3. After this date, items will be sent to experts in the field and lay persons for their review and ethics approval for distribution of the items will be obtained it is likely that items will be distributed online throughout the summer months
- 4. Portions of the manuscript (proposed meta-analysis) detailing the connection between discrimination and health variables are currently being completed
